It is meant for everyone concerned with the use of antibiotics in developing countries, including doctors, medical assistants, pharmacists, officials in health ministries, and medical students. Throughout the book, treatment recommendations are made for 1 antibiotics from the WHO list of essential drugs. For example, emphasis has therefore been put upon chloramphenicol as a stable, unexpensive and widely available oral agent suitable for the treatment of severe bacterial infections like septicemia and meningitis. So-called "international chemotherapy" with modern cephalosporins and acylaminopenicillins has been outlined for comparison. Since it is the aim of the book to base treatment recommendations on data from developing countries, many data on the etiology of common bacterial infections in developing countries have also been included. Most of the data are from African, English-speaking developing countries, but references have been made to the literature on South East Asia, India or Papua New Guinea, where appropriate. On the other hand, pertinent data were not available in every instance, so that several statements and recommendations had to be made as "best guess". The authors are aware of these imperfections and will welcome comments from the readers.
